Mel Morris has over 21 years experience working in historic environment conservation.

Whilst employed by Derbyshire County Council and Nottingham City Council, Mel's work was focussed on major Grade I and II* historic buildings, developing grant-packages and working with "buildings at risk" & running conservation-led regeneration schemes.

Mel has worked on a number of high-profile strategic conservation projects including Wirksworth Town Scheme, assistance with the World Heritage Site nomination for the Derwent Valley, the restoration of two major market places in Belper and Bolsover (with Heritage Lottery Funding), Conservation Area Partnerships for a number of market towns and the development of the first Heritage Economic Regeneration Scheme for Nottingham.

Between 1999 and 2001 whilst working for Nottingham City Council Mel undertook a Conservation Statement and Development Brief for Colwick Hall, a Conservation Plan for Wollaton Hall and Park, advised on lottery bids and implementation (Nottingham Arboretum and Wollaton Hall), and advised on listed building refurbishment and works at Nottingham Castle (grade I), the Adams Building (grade I), and Clifton Hall (grade I). Mel provided advice to "Nottingham City Museums and Galleries" on three major museum sites; Wollaton Hall (Natural History Museum and Industrial Museum), Castle Museum, Newstead Abbey, advice which continued for several years after she set up the consultancy.

Since establishing in private practice in December 2001, Mel has:

- developed the business to create a strong, reliable & professional team of associates; graphic designers, photographers & research specialists
- produced 34 Conservation Area Character Appraisals & several Management Plans
- produced 2 Conservation Management Plans for major scheduled sites in association with a firm of well respected conservation architects
- advised Nottingham City Council on lottery bids & conservation planning for three museum sites; Newstead Abbey, Wollaton Hall, and Nottingham Castle
- been part of the successful team to develop the £9 million restoration scheme for Wollaton Hall & Park

- advised on development control matters concerning major listed buildings for both public and private sectors
- produced supplementary planning guidance on listed buildings, conservation areas and archaeology & a buildings at risk register

Team Working and Liaison:

Mel Morris has developed close working relationships with professionals within Local Authorities (e.g. highway engineers, building control and environmental health officers, architects and structural engineers, education, museum and landscape staff), and with organisations such as the National Trust, English Heritage, local Building Preservation Trusts, Groundwork Trusts, local and regional museums and Regeneration Bodies.

Since establishing a consultancy, Mel has continued to work with professionals in a variety of disciplines & has built up a detailed network of associates, with expertise in archaeology, graphic design & environmental education, museum conservation & collections care, conservation architects, architectural paint analysis, historic landscape assessment & landscape designers.

Conservation-led Regeneration Schemes:

Mel Morris has direct experience of working within large multi-disciplinary teams and responsibility for management of regeneration-based grant schemes, encompassing market towns and inner-City areas including preparation of successful bids to fulfil funding requirements. Examples;

Wirksworth Town Scheme (Derbyshire) 1988-1992

A large market town with particular problems from loss of its principal industry (quarrying) and a textile manufacturing base, one of the first such schemes to be established in the U.K. Mel Morris managed and supervised the English Heritage/ local authority partnership scheme after it had been established for a number of years. Projects included the restoration of the 16th century Almshouses with a local Housing Association, the re-paving of the Lychgates and Cook's Yard using traditional materials, re-roofing of the grade I listed church.

Belper Conservation Area Partnership (Derbyshire) 1995-1999

A large industrial town with problems from the loss of the hosiery manufacturing and cotton-spinning base. Mel Morris managed the scheme, a local authority / English Heritage partnership (later the HLF), & monitored/supervised work on site. Projects included the restoration of terraced millworkers cottages, the restoration of Public Baths and town centre shopfronts, feasibility studies on the grade II* listed cotton mill (North Mill & Weir) and Congregational Church, initiatives to promote environmental education within the town, and the full re-paving/restoration of the Market Place with Heritage Lottery Fund grant-aid (scheme of £½ million). Mel was responsible for co-ordinating all funding for the market place re-paving scheme, public consultation, & working alongside the resident engineer in the project team providing design advice, sourcing materials & specialist contractors.

Bolsover Conservation Area Partnership Scheme (Derbyshire) 1995-1999

An historic market town that expanded rapidly in the late 19th century with coal mining. By the late 1980's the Pit was redundant and the area was suffering massive unemployment. Mel Morris co-managed the CAP scheme a joint-English Heritage/ local authority scheme; later an HLF funded scheme. Projects included: the re-paving and traffic management of the market place (HLF-funded scheme co-designed by County highway engineers and Mel Morris), the re-construction of the walls and gardens to the model colliery village, the design and production of town trails, the environmental enhancement of scheduled ancient monument earthworks in association with the local Groundwork Trust, the restoration of critical Buildings at Risk and the restoration of important shopfronts.

Nottingham (Alfreton Road & Gamble Street) Heritage Economic Regeneration Scheme 1999-2001

An area of inner-city deprivation that has also received New Deal funding. Social problems and the loss of the lace-manufacturing base have created difficulties in finding sustainable uses for the massive lace & textile factories and for regenerating the shopping streets. Mel Morris managed the scheme on behalf of Nottingham City Council / English Heritage. Projects included; restoration of the redundant Provident

Works for small business use in association with Nottingham Regeneration Limited, the restoration of an Italian restaurant and use of upper floors for flats, the re-fronting of several small commercial properties, incorporating traditional shopfronts and the associated bringing into use of upper floors for flats.

Mel Morris has therefore:

- extensive experience of managing and providing technical advice on conservation-based regeneration grant schemes both within the inner-city and market towns
- a proven track record of successful Partnership schemes in historic areas working in close association with English Heritage and the Heritage Lottery Fund. During her management of projects within Derbyshire and Nottingham no scheme was underspent in any year. Budgetary control has ranged from £1/4 million (over 3 years) for Cromford and Belper CAP Schemes, to £400,000 for Nottingham (Alfreton Road & Gamble Street) Heritage Economic Regeneration Scheme, to £1/2 million enhancement scheme for the restoration of Belper market place
- experience of project management of complex schemes
- detailed knowledge of requirements and standards of specification and site work for heritage-based grant schemes

Buildings at Risk:

Extensive experience of facilitating rescue packages for listed buildings at risk, production of the "Buildings at Risk" register for both Derbyshire and Nottingham, preparation of repairs notices, development briefs for feasibility studies, appointment of consultants, submission of bids for funding (including the Heritage Lottery Fund).
